Financial

Bobbi Catone reviewed the year end and monthly financial reports.

Maintenance

Ron Parker, maintenance supervisor, reviewed the year to date and his future goals before the school year's end for the facilities and maintenance.

Transportation

Jack Denison transportation supervisor, discussed the current grants that have been applied for that would pay for electric buses. He talked about the benefits and cons of the electric bus system and what it would take to implement one in the district.

Administrator

Trisha Roach discussed the struggles that the HS staff has dealt with over the winter months, from personal issues to sickness, and they have shined through to support students and each other. The counseling office is offering personal appointments for families needing help with financial aid. The student-led art auction in December was very successful, and the Teen Kitchen program cooked and served the dinner for the event. The music concert was very well attended by families, staff, and community members. The pep band started in January and is making steady improvements and fans are really enjoying having them perform at games again. Mrs. Roach gave a comparison between multiple years of Algebra numbers and statistics. The HS is sending out progress reports at the halfway mark of the quarter. Online math tutoring through a free program of Microsoft has started.

Kelwy El-Haj reported on the enrollment numbers in the middle school. The MS staff development was a GLAD (guided language Acquisition Design) refresher training. April Cole has begun 6th grade camp preparations and has received an outdoor school grant which will be used to improve the conditions of the campground for 6th grade camp. It will be used to purchase mattresses and dishes. Brian Ellis received and grant for improvements to the existing greenhouse. There is a Migrant meeting on February 21 at 6 pm. The middle school has been actively working on its vision and mission.

Superintendent

Kevin Young discussed the Kiwanis groundhog brunch happening on Saturday. Mr. Young also talked about MTSS director Kristi Krieg applying for and receiving a Healthy School Healthy Kids grant for building a sizeable multi-use structure down by Outreach and Tennis courts that can be used for physical education, wrestling room, etc.
